2. APICON 2025

API had a very successful 80th Annual Conference at Kolkata. The APICON 2025 was held in Kolkata from January 23-26th 2025

The conference venue was The Biswabangla Mela Prangan situated in the heart of Kolkata on the EM Bypass, a state-of-the-art conference cum exhibition center.

Attended by nearly 10,000 delegates and faculty it was an enormous success. There were main 12 halls, four PG halls and 4 workshop halls. Almost 1400 papers were presented by PGTs. A new oration the UN Brahmachari oration was started

Dedicated halls for collaborative session with other societies, Global summit and PRF hall were carried out. The decoration, artwork in the halls was appreciated by all.

Apart from the Progress in Medicine, Medicine Update a new book Clinical compendium was released.

There were Around more than 750 lectures, 20 Symposia, CPC, and 18 workshops were held. A large number of dignitaries, foreign speakers and eminent national faculties were being deliberated on contemporary topics.

Panel discussions debates and composite sessions of case report or short paper with two related lectures were there. Over 1000+ Speaker and Chairpersons added value to the scientific deliberations.

Dr. Jyotirmoy Pal was installed as President of API. He was also the Chairman of the Scientific Committee. He and Dr Sekhar Chakrabarty were the Joint organizing secretaries. Special congratulations for a very well planned scientific programme. It was appreciated by all the delegates.

On behalf of all my esteemed colleagues of the Editorial Board, I take great pleasure in presenting to you the annual report of the activities of the Journal of the Association of



Physicians of India.

The journal has received 893 articles during the year 2025 out of which 127 were provisionally accepted for publication 448 are with referees for evaluation and re-evaluation. 47 were returned to author for modification, 559 were rejected, 25 articles were withdrawn by Authors.

We have published 116 Original Articles, 58 Review / Update Articles, 124 Case Reports, 12 Point of View, 13 Pictorial CME's and 21 Correspondences.

JAPI published supplements on "Adult Immunization", "Epidemiology and Treatment Patterns of Acute Cough in Adults and Elderly", "Ready World Data on Dehydration" have already been posted along with May, June and August 2025 issues of JAPI respectively. The supplement issue on "Mineralocorticoid Receptor Antagonist in Heart Failure: Evolution, Present Insights, and Future Directions" has been published along with January 2026 issue of JAPI.

For clearance the backlog of Case Reports we have start the Online Supplement copy of Case Reports, published along with the July, Sept & November 2025 issue of JAPI.

JAPI has started the fast tract reviewing and publication for Industry Supported articles to attract the commercials and we receive the positive response.

Annual Report of Physicians Research Foundation

PRF ANNUAL REPORT 2025-2026

The concept of the **State PRF Wing** was introduced this year, and many states have already constituted their respective wings. Our dynamic PRF members have been entrusted with the responsibility of monitoring state-level research activities, including multicentric studies and disease registries (e.g., hypertension, sudden cardiac death, malaria, etc.).

As **Chief Editor** of the book "*Research Made Easy*", a clinician-oriented guide aimed at simplifying medical research for practicing doctors, the book was released at **APICON 2025, Kolkata**, and **5,000 copies** were distributed to all delegates. PRF-logo ties were also distributed to our members.

We organized a **national-level Good Clinical Practice (GCP) Webinar Series** from June to July 2025 for doctors across India, with the objective of promoting ethical and regulatory compliance in clinical research. This GCP program consisted of **four focused sessions** comprehensively covering GCP guidelines, **Indian Council of Medical Research (ICMR)** guidelines, and ethical principles governing biomedical research. **GCP certification** was issued to participating doctors upon successful completion of the program, thereby reinforcing ethical awareness and standardized research conduct.

We conceptualized and conducted a **national-level online Research Methodology Webinar Series** for doctors across India, comprising **ten structured sessions** that comprehensively covered all core aspects of medical research methodology. The series addressed key domains including research design, sample size calculation, data analysis, manuscript preparation, publication processes, and research ethics, thereby significantly strengthening research competencies among participating clinicians and academicians.

On behalf of the **Association of Physicians of India (API) - Physician Research Foundation (PRF)**, we successfully organized and led a **Research Week Celebration** from **07.11.2025 to 14.11.2025**, conducted in online mode. The Research Week spanned **seven consecutive days**, with daily sessions, and included **seven distinct academic events** in the form of expert webinars and panel discussions focusing on research, ethics, and academic leadership.

This year, **approximately twenty research projects** from various states, submitted through state chapters, have been scrutinized and are pending financial approval.

The **Shield Lipid Awareness Program** and the **Home Blood Pressure Monitoring**



Consensus Project are currently in the pipeline.

As **Chief Editor** of the forthcoming book "*Research Ethics Made Easy*", the focus is on ethical principles, regulatory frameworks, and the responsible conduct of medical research.

The book "*Research Ethics Made Easy*" is scheduled for release at **APICON 2026, Patna**, and will be distributed nationwide to doctors across India.

The good news is that we have **collected Rs.33 lakhs**, and we expect to collect an additional **Rs.25 lakhs from the pharmaceutical industry** for our research programs. This amount is **in addition to Rs.45 lakhs allotted by API Headquarters**. This amount will be utilised for research projects

Annual Report on API house

API House continues to be a significant asset of the Association of Physicians of India, contributing steady financial returns and long-term strategic value. The property is leased to BSS Foundation under an agreement originally valid up to 2029, generating a monthly rental income of ₹7,00,000, which has been received regularly.

During the 2025 monsoon, the building sustained rain-related damage and because of work done by tenant at second floor. A post-monsoon assessment and as it was notified by tenant also, indicated the need for urgent repair work to prevent further deterioration and to ensure structural safety.

As per Clause 8 of the lease agreement, the agreement stands null and void in view of the required major structural repairs, and the tenant was accordingly asked to vacate the premises immediately. During discussions, the tenant stated that he believed the agreement to be valid for five years. It was therefore suggested that, subject to approval of the Governing Body, he may be permitted to continue as a tenant after completion of the repair work and obtaining the safety certificate. Subsequently, however, the tenant sent multiple emails and letters stating that he would not vacate the premises and has demanded compensation running into crores, failing which he has indicated that he may resort to legal action.

Two repair quotations have been received so far by the help of api house committee, the latest being approximately ₹56 lakh, excluding electrical and other subsidiary charges. One additional quotation will be obtained which is under process, after which a decision will be taken either by selecting from the available options or by proceeding through a formal tender process as suggested by the finance committee looking to the paucity of time and dire need to start the repair work at earliest.

All vendors will be required to issue a structural stability certificate on completion of work. The api house committee is working on it and will take all required clearances and will do compliances including NMMC will be informed of the repair activity, and provision for rainwater harvesting will be incorporated.

The proposed repair work is expected to commence at the earliest, with an estimated duration of six months. The Governing Body will continue to be kept fully informed, and necessary approvals and guidance will be sought at each stage.

The api house committee will be monitoring the audit and repair works and will seek legal advice and proceed for and supervise the legal proceedings if the need arises after doing consultations with the lawyers

The Association of Physicians of India is a Society registered under the Societies Registration Act, 1860 vide registration certificate no.25 of 1944-45 dated 23rd December 1944 issued by Asst Registrar of Joint Stock Companies, Chingleput District, Madras. The main object of the Society is to encourage and advance the knowledge, study and practice of the science of medicine in all ways. The objects also include to encourage research, including experimental work, in the science of medicine, organize, establish, conduct, superintend or control institutions for promoting, whether directly or indirectly, the study of and research in problems relating to the science of medicine, to hold meetings and organize conferences, exhibitions, study circles or conventions for the study and discussion of problems relating to and allied with the science of medicine.

The Society has been granted an exemption under section 12A of the Income Tax Act, 1961, vide letter no. CH/ 310-A-TC(I) issued by Commissioner of Income Tax, Mumbai City V, (application no INS/3657) dated 23rd March 1977. The exemption has been granted with effect from 27th June 1973. The Society also has been issued certificate under section 80-G of the Income Tax Act 1961 vide order no DIR (E)/ MC/80G/945/2009-10 dated 21st April 2009 and the validity period was 8th August 2008 to 31st March 2011. As per the amendment vide Finance (No 2) Act 2009, 80G certificates which expires after 1st October 2009 are valid in perpetuity unless withdrawn by the concerned authority. Further, as per the amended requirement of Income Tax, the Trust has applied for the renewal of 80G / 12AB on 28th August 2021 and the trust has received the approval from the appropriate authority on 24th September 2021 for the period from AY 2022-23 to AY 2026-27.

2. Significant accounting policies**a. Basis of preparation of financial statements**

The Society is a Level III entity- Small and Medium Sized Enterprise (SME) as defined in the Applicability of Accounting Standards to non-corporate entities. Accordingly, the Society has complied with the Accounting Standards as applicable to a Level III entity. The Society is not required to present the Cash Flow Statements, Related Party Disclosures, Segment reporting and Discontinuing Operations disclosures as required under the relevant Accounting Standards. Further, the Society has availed an exemption in respect of the Accounting Standard 15 (revised) on 'Employee Benefits' and Accounting Standard 19 'Leases'.

The financial statements of the Society have been prepared under the historical cost convention on the accrual basis of accounting in accordance with the applicable accounting standards issued by the Institute of Chartered Accountants of India and the Generally Accepted Accounting Principles ("GAAP") in India. As per the revised criteria of the ICAI, the Trust will be categorized as an MSME (Non-Company Entities) under the new two-category system for the year ended 31st March 2025.

b. Use of estimates

The preparation of financial statements in conformity with Indian GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates. Any revision to accounting estimates is recognized prospectively in current and future periods. Contingencies are recorded when it is probable that a liability will be incurred, and the amount can be reasonably estimated.

c. Fixed assets

Fixed assets are stated at historical cost less accumulated depreciation. The cost of fixed assets includes taxes, duties, freight and other incidental expenditure related to acquisition and installation.

d. Depreciation

Depreciation is charged on pro-rata basis to the period of use on the written down value method using the rates of depreciation as prescribed under the Income Tax Rules, 1962 and those rates of depreciation are adequate to reflect the estimated economic useful life of the assets as estimated by the management. The primary rates of depreciation are as follows:

Intangible- Software	25%

Licensed software is being amortized as per period for which license is valid.

Leasehold land is not amortized considering that it is not allowed as expense under the provisions of Income Tax.

e. Retirement Benefit

The Society's obligations towards various employee benefits have been recognized as follows:

Short term employee benefits

All employee benefits payable wholly within twelve months of rendering service are classified as short-term employee benefits. Benefits such as salaries, allowances, are recognized in the Income and Expenditure Account in the period in which the employee renders the related services.

Post-employment benefits

Defined contribution plans:

The Society is not required to be registered with under the Employees Provident Fund Act as the number of employees is below the threshold limit and Society has not opted for voluntary registration. The society however gives a fixed amount for the employee to deposit under their respective Public Provident Fund account which contribution is charged to the Income and Expenditure Account.

Defined benefit plans:

In respect of gratuity, the liability is determined based on liability on the basis that all the employees are to retire on the reporting date. In view of limited number of employees, the Society has not carried out the actuarial valuation.

The Society has taken premises on operating lease. Lease payments under operating lease are recognized as an expense in the Income and Expenditure Account on a straight line basis over the lease term.

g. Income Recognition

Donation received in cash or in kind is recognized as income when the donation is received. Donations made with a specific direction that they shall form part of the corpus of the Trust are classified as corpus donations, and are directly reflected as trust fund receipts in the balance sheet. Interest on deployment of funds is recognized using the time-proportion method, based on underlying interest rates.

Other revenue in nature of advertisement and publishing is recognized on Mercantile basis except in respect of Society's share from APICON conference is recognized on the basis of the statement of account received from the organizer and in case the statement is not received to the extent of the amount received and balance when the statement is received and/or account settled with the organizing committee.

Contributions for the objects of the trust (other than members) and Contribution received from ICP Dean are accounted for on cash basis.

Rent income is recognized based on the terms of lease agreement.

h. Investments

Deposits with banks are shown under Balance with bank and Deposit with others is shown under the head "Investments". All the investments are valued at cost.

3. Corpus fund

Corpus fund relates to funds contributed by the founder members on incorporation and fees received on admission of a Member in the Society.

4. Restricted / Endowment fund

Restricted Funds are funds that are to be used in accordance with the specific restrictions imposed by donors. The cost of administration of such funds is charged against the specific fund in line with donor agreements or understanding as arrived with the donor. The interest earned on the funds pending utilization is credited to the said fund. Amount spent from individual earmarked fund in excess of relevant fund income is charged off to Income & expenditure A/c.

5. General Fund

General funds are unrestricted funds which have not been designated for any specific purposes. They are available for use at the discretion of the management in furtherance of the general objectives of the society.

Society's voluntary contribution to public provident fund maintained by the respective employees been recognized in the Income and Expenditure Account.

Defined benefit plans:

Gratuity is payable to all eligible employees of the Society on resignation, retirement, death or permanent disablement, in terms of the provisions of the Payment of Gratuity Act. The liability for gratuity, as determined on arithmetical basis as on 31st March, 2025, is Rs. 58,00,661/- (previous year- Rs. 54,67,669/-).

7. Income Tax refund for prior years is yet to be issued by the department. The Board of Trustees has decided to take necessary action to claim the refund dues on these accounts & hence TDS deducted is considered recoverable. Further, the department has raised demand of Rs. 53,20,296/- for A.Y. 2011-12, Rs. 15,23,894/- for A.Y. 2012-13, Rs. 62,67,028/- for A.Y. 2013-14 & Rs. 98,97,100/- A.Y. 2014-15, Rs. 1,20,46,880/- A.Y. 2015-16, Rs. 2,84,91,139 A.Y. 2016-17 and Rs. Nil demand for A.Y. 2017-18 and A.Y. 2018-2019. In addition, the Trust has filed an appeal to the Income Tax Appellate Tribunal against the order of the Commissioner of Income Tax (Appeals) upholding the order of the Assessing Officer for the years A.Y. 2011-12 to A.Y. 2013-14. Hon'ble ITAT has decided the appeal in the favors of the Trust and deleted the addition made by the assessing officer.

Further, in the month of March 2022, CIT(A) has decided the appeal in the favour of the trust for A.Y. 2014-15 to A.Y. 2018-19. Subsequent to year end, department has preferred before ITAT against the order of CIT(A) for A.Y. 2014-15 to A.Y. 2017-18. Hon'ble ITAT has issued the Order in favour of the Trust for the 2014-15 to A.Y. 2017-18 and directed the Assessing Officer to allow exemption under section 11 in respect of the Income of the Trust.

Accordingly, above demands raised for AY 2011-12 to A.Y. 2017-18 will be reduced to Nil and the Trust will be entitled to tax refund & interest thereon as per the Order-giving effect which is awaited as on the date of closure of this accounts for the year ended 31st March 2025.

Additionally, the Principal Commissioner of Income Tax (Pr. CIT) has filed an appeal against the order of the Income Tax Appellate Tribunal (ITAT) in ITA No. 972/Mum/2022 for the Assessment Year 2015-16, dated 30th June 2022. However, the ITAT dismissed the appeal filed by the Revenue. In response, the Department has further appealed the matter before the Hon'ble High Court. The case is currently under trial, and the Trust has engaged a law firm to represent its interests in the matter. Multiple hearing dates have been scheduled by the Hon'ble High Court, and the appointed law firm has duly attended and provided updates throughout the year. As of 31st March 2025, no final conclusion has been reached in the case.

Based on the above development, the management of the Trust believes that the demands raised for the other AY are not payable and accordingly no provision is made in the books.

8. There is outstanding TDS demand of Rs. 7,33,720/- on income tax portal as per TRACES. However as per management there is no such outstanding liability and the Society is in the process of filing the required application for rectification of quarterly TDS return filed and does not expect any outflow of payment. Accordingly, it is not considered as contingent liability.
9. Provision for contribution to charity commissioner is not provided for by the trust, as the trust is exclusively involved in advancement of secular education as per Section 58. Further, as per the Bombay High Court Order passed on 25th September, 2009, the Charity Commissioner's office has been restrained from collecting administrative funds from charitable trusts across



Maharashtra. Accordingly, the trust has not provided / paid the said contribution to the office of charity commissioner.



Opinion


